## TERMS OF CONTRACT & CONDITIONS OF PARTICIPATION FOR EXHIBITORS

**Definition:** The "Exhibition" shall mean INTERNATIONAL DENTAL LAB EXPO & CONFERENCE (IDLEC). The "Exhibitor" shall mean the party to whom space has been allotted in the exhibition.

"Exhibition Manual" shall mean the handbook of the organizer containing such regulation as may deem reasonable to the Organizer relating to the Exhibition, the Venue and the Exhibitor's attendance and conduct at the Exhibition and the "Organizers" shall mean Ivory Exhibitions & Conferences.

Agreement & Allocation of the Stands: A binding contract shall come into existence between the Exhibitor and the Organizer on acceptance of the Application for Participation form in writing by the Organizer. The basis of allotment will be neutrality, aesthetic appeal, conformity with floor plan layout and product groups. Allocation will be subject to receipt of all advance payments. Allocation of stand numbers location will be communicated in writing to all applicants by the organizers and this will conclude the contract for participation in the exhibition between the organizer and exhibitors. No Changes to these Terms shall be valid unless signed in writing by the duly authorized representatives of both the Exhibitor and the Organizer.

Alteration of Space Allotted: The organizers reserve the right at any time and from time to time, to make alterations in the ground plan of the Exhibition, as may in their opinion be necessary and to alter the shape, size of position of the space allotted to the Exhibitor. However no alteration to the space allotted will be made in such way as to impose on the exhibitor any greater liability for rental than that undertaken in the contract.

**Obligation of Exhibitors:** On confirmation of the stand allocation, an Exhibitor is obliged to make payments for the balance cost of participation, and cost for additional services availed of, as per schedule. Failure to adhere to the payment schedule will lead to forfeiture of all payments made. An Exhibitor is bound by these conditions of participation and Rules and Regulations for Exhibitors issued from time to time by the organizers and are obliged to enforce compliance thereof from his staff, agents or representatives. The Exhibitor shall observe and comply with the Exhibitor Manual at all times. The Exhibitor remains obliged to participate even if the Exhibition is postponed for reason deemed necessary by the organizers.

**Cancellation:** A contracted exhibitor requesting to cancel participation for any reason shell be liable to the following cancellation charges:-25% cost 6 months before opening Exhibition date. 50% cost - Between 6 to 3 months before opening Exhibition date. 100% cost - 3 months before opening Exhibition date. All requests for cancellation must be made in writing and dated, this date being that which shall pertain in calculating the charge payable.

Payments: Upon receipt of the completed exhibition space / stand contract, the organizer will confirm space / stand to the exhibitor and will issue a proforma invoice for the full rental cost of the allotted space / stand. 50% payment of the total Proforma invoice charges within 15 days of the date of Proforma invoice. 50% payment is due on 30<sup>th</sup> September, 2023. All invoices issued on or after 30<sup>th</sup> Sept., 2023 are subject to 100% payment.

**Right of Organizers:** The organizers reserve the following rights – a) To reject any application for space without assigning any reasons. b) To amend these conditions for participation and additional Rules & Regulations for participants from time to time, this shall be binding on all participants. c) To change the stand location or to make certain changes, alterations, curtailments in the final allotments of stall areas with respect to that originally booked by the exhibitor. d) To postpone, relocate, curtail, extend or abandon the exhibition or close some or all sections temporarily or permanently. If unforeseen circumstances so require, in such an eventuality, no exhibitor shall be entitled to withdraw from the contract to claim any compensation or damage. e) To refuse permission to an exhibitor to clear his stand if he has not discharged all debts to the organizers, and to retain his exhibits or other goods as collateral security till the debts are cleared and charge demurrage and administrative charges.

**Insurance Coverage & Organizers Indemnity:** The onus is on the exhibitor to obtain insurance coverage against all risks arising from the to and fro transport of exhibits and their display during the exhibition, particularly against theft, etc. A comprehensive insurance is recommended. The organizers shall not be liable for personal injuries and material damage including theft of any exhibit / good. To be bound by the provisions of these conditions for participation, the exhibitor expressly exempts the Organizers from any claims for damages that may be made by third parties.

**Imported Exhibits / Foreign Principals:** As per directives of INTERNATIONAL DENTAL LAB EXPO & CONFERENCE (IDLEC), the nodal agency attached to Ministry of Commerce, Govt. of India, which approves all International Exhibitions, duty-free import facility (Under ATA Carnet or Re-Export Bond supported by the bank Guarantee) is available to only foreign exhibitors who have paid participation charges in foreign exchange at the rate applicable to foreign exhibitors. Indian exhibitors interested in displaying exhibits imported from foreign principals, must ensure that each of their foreign principals register as an exhibitor, on payment of space charges as mentioned from time to time for foreign exhibitors. At the request of Indian exhibitor and foreign principal, an integrated stall with their combined space will be provided.

**General** / **Rules:** In addition to the above the exhibitor shall abide by general rules of the Exhibition venue for safety and maintenance as well as for aesthetic appeal. No hoarding, banners etc. will be allowed on the premises of the exhibition hall and the complex or on the roads in the vicinity. Exhibitors must take extra care to ensure that there is no damage to the floor or structural property of the exhibition hall. **Permission** / **Approvals:** All verbal agreement, permission, individual approvals or special authorization shall be deemed to be valid only if confirmed in writing by the organizers.

**Failure of Services:** The organizers will use their best endeavors to ensure the supply of the services of the Exhibition center and of the authorized contractors, but they shall not incur any liability to Exhibitor for any loss or damage if such services shall wholly or partially cease to be available.

**Force Majeure:** Under the conditions of force majeure, which also include strike, lockout, closure, riot, the organizers reserve the right to alter the opening dates and duration or curtail, cancel or suspend in whole or part of the Exhibition. In such an event, the Exhibitor is entitled neither to rescind the contract not to claim any compensation or damages. In case of cancellation of exhibition, refund will be made after deducting the proportionate cost already incurred by the organizers, and the cost of any additional services provided to the exhibitor. **Final Decision:** In case of any dispute, in interpretation of conditions for participation, laid down by the organizers or between exhibitors, the final decision of the Organizers Ivory Exhibitions & Conferences.

shall be binding on all parties.

**Domicile and Jurisdiction:** The implementation of these regulations or supplementary stipulations laid down by the organizers relating to the exhibition shall be deemed to be domiciled at the office of the Delhi Courts. All disputes arising shall be judged according to Indian Laws and subject to Delhi jurisdiction.
